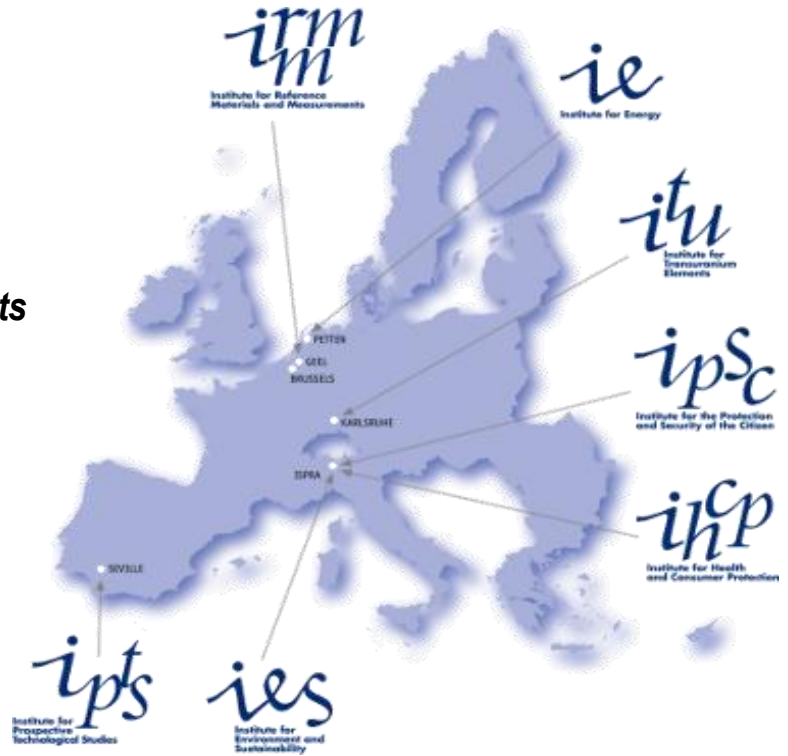

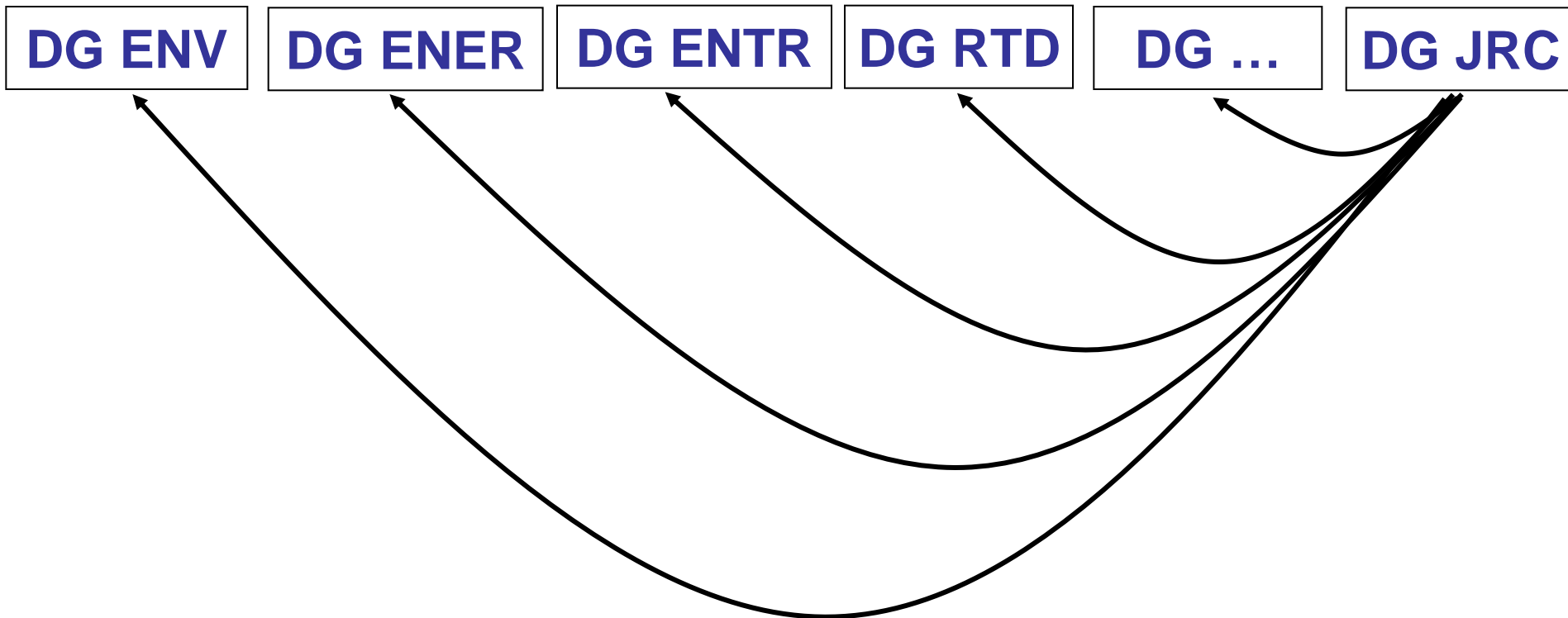

- Ecodesign preparatory study
- EU Ecolabel preliminary report
- Additional aspects from Energy Labelling and GPP
